(hereinafter referred to as
"the Museum")

1. Permission is granted only for one usage in one publication, one edition, and in one language. Additional language editions and subsequent revised new editions will be considered upon application. Photographic material may not be reused without the prior written permission of the Museum. Under no circumstances may color transparencies be duplicated. Usage on the Internet and all other forms of electronic communications are excluded.
2. The complete credit line as specified must appear on the same page as the reproduction, on the opposite page or on the reverse. If the Museum's reproduction(s) would be the only one(s) in this publication giving the full information in one of the above stated location, then you may list only the artist's name, title of work, and date. However, the complete documentation must appear elsewhere within the book. In the case of filmstrips, visual credits must appear at the beginning or at the end.
3. The object(s) may not be cropped, bled or overprinted and nothing may be superimposed on the reproduction(s). A specific detail must be approved in advance by the Museum, and the word "detail" must appear in the caption. Reproduction(s) must be full-tone, black and white or full color, and must be printed on white stock.
4. In the case of works by living artists and/or subject to the 1976 Copyright Act, written permission must be secured by the applicant from the artist, their agent or copyright owner.
5. The Museum assumes no responsibility for royalties or fees claimed by the artist or other third parties.
6. In addition to the rental fee, a charge equal to the replacement cost will be assessed for any color transparencies not returned within three months or returned in damaged condition.
